Count I. Discharge/shoot firearm at or from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - 1st offense (31152130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about March 18, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, a 2012 Ford Fusion.

Count II. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 18, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count I, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

Count III. Discharge/shoot firearm at or from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - 1st offense (31152130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about March 29, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, 1999 Pontiac Grand Am.

Count IV. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 29, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count III, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

Count V. Discharge/shoot firearm at or from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - 1st offense (31152130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about March 31, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, 2013 Toyota Prius.

Count VI. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 31, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count V, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

Count VII. Discharge/shoot firearm at or from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - 1st offense (31152130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about April 2, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, a Ford F-250 Supercab.

Count VIII. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about April 2, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count VII, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

Count IX. Discharge/shoot firearm at or from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - 1st offense (31152130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about April 4, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, a Chrysler Town and Country.

Count X. Armed criminal action (31010130)

Count XI. Discharge/shoot firearm at or from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - 1st offense (31152130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about April 4, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, a 2007 Hyundai Elantra.

Count XII. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about April 4, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count XI, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

Count XIII. Discharge/shoot firearm at from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - physical injury or death (31151130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class A felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about April 4, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, 2002 Buick LeSabre and, as a result of the above described conduct, suffered injury or death.

Count XIV. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about April 4, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count XIII, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

Count XV. Discharge/shoot firearm at or from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - 1st offense (31152130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about April 5, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, a 2004 Ford Taurus.

Count XVI. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about April 5, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count XV, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

Count XVII. Discharge/shoot firearm at from motor vehicle/shoot at person, another motor vehicle or building/habitable structure - physical injury or death (31151130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class A felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 571.030.9, RSMo, in that on or about April 6, 2014, in the County of Jackson, State of Missouri, the defendant, knowingly discharged a firearm at a motor vehicle, a 2011 Hyundai Sonata, and, as a result of the above described conduct, suffered injury or death.

Count XVIII. Armed criminal action (31010130)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about April 6, 2014, in the County of Jackson, State of Missouri, the defendant committed the felony of Unlawful Use of a Weapon charged in Count XVII, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Unlawful Use of a Weapon by, with and through, the knowing use, assistance and aid of a deadly weapon.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.
