- (b) I left the hospital late that night with McMahon. I told him that I could not be with him any longer. He got very upset and he tried to run our car off a cliff. He told me that if he could not have me, no one could, that he would kill me by driving me off the cliff. He was willing to kill me, himself and his friend in the back seat.
  - (c) The police arrived and the car, which crashed onto the beach. I told the police that I'd been driving and that McMahon grabbed the steering wheel and steered the car off the cliff. As far as I can remember, he was not arrested.
- 5. I sold McMahon's truck and he came after me with a metal pipe and swung it at my head. I ducked and he hit the rear windshield of my father's car, smashing it. McMahon was arrested for menacing. He was in jail for several weeks and was released.
- 6. He got out of jail several weeks before the murders and did not have any money. In order to make some quick money, he and Jason Kinser decided to "cut" the dope with baking soda.
  - 7. Less than 24 hours after the murders, in the early morning hours of November 24, 1998, before there was any press coverage, McMahon called me and told me that Jason and Suzan were dead. I was very suspicious because the news had not released any information regarding the murders or the identity of the victims.
- 8. During that phone conversation, McMahon, who was very excited and worked up, told me that "you should have seen the look on Suzan's face." He said that he witnessed the girls run for their lives and hiding under the trailer. When I told him that I did not want to see him again, he said told me that I was not "out of the game," that "I'm going to kill you." He also referred to me as "JuJu," which is a nickname my mother gave me when I was little. He told me that he was there, during the killings, that Suzan and Celeste were running from the killer and ended up hiding under the trailer.
  - 9. I also witnessed Thomas McMahon at Bimla Boyd's house/property using methamphetamine with Kinser and with Bimla Boyd. McMahon was a regular at Bimla Boyd's house. On at least one occasion, I witnessed Bimla Boyd use methamphetamine. She put the substance on a foil sheet, took out a small pipe and inhaled it. Additionally, Bimla Boyd was a drug addict. She allowed Kinser to live on her property in exchange for drugs. Bimla was very odd. She acted "twitchy" and was very unpredictable.
- 10. Kinser told me that he had been providing "cut" to Boyd, which meant that he was cutting the drug with baking powder. I told him he was crazy for giving fake dope to the woman who was allowing him to live there.
